# Thesis description

## Title: Incorrect information in tax law

EATLP Poster Program for Doctoral Students

#### **Purpose**

The purpose of the PhD project is to examine and analyse the legal system which applies if the tax payer leaves incorrect information in his or her declaration of income. If incorrect information is given in the declaration of income, the result can be both economic sanctions and penalties. Economic sanctions and penalties usually have an impact on the person who is being investigated by the tax authorities. Therefore it is of great importance how the rules are framed and how they are applied by the Swedish tax authorities and by the courts. The main focus of the project is to examine how the rules are applied and to identify the criteria which lead to economic sanctions and penalties.

The legislation which applies on incorrect information in the declaration of income is applicable in three different situations.


- 1. When the Swedish tax authorities decide about tax surcharge.
- 2. When the Swedish tax authorities decide about additional assessment
- 3. The court's decision whether a criminal acts has been committed or not.

# Letter of recommendation

They also have a lot of moot courts during their law education, so I would say that the students at Örebro University, including Hanna Grylin, are very well trained in expressing themselves orally and in writing. Hanna Grylin has developed those abilities further during her time as a doctoral student. Hanna Grylin has also a natural talent on these fields.
