The University of Luxembourg and the ATOZ Chair for European and International Tax Law in the Faculty of Law, Economics and Finance cordially invite you to the **Annual Congress of the European Association of Tax Law Professors (EATLP)**, to be held from **June 8 to 10 2023 in Luxembourg**.

For our young institution (the law department was created less than 20 years ago), it is a great honour and responsibility to host the most important annual congress of the academic tax world. We are grateful for both the trust put into us and the organisational support we have received from the EATLP.

The Congress will be held in the heart of the legal and financial district of Luxembourg City in immediate proximity to the European Court of Justice. Proceedings will be organised (on Thursday and Friday) at the **European Convention Center Luxembourg (ECCL)**, and (on Saturday) at the **Law Department building**.

Both venues are easily and quickly accessible from all recommended hotels either on foot or via short ride on Luxembourg's excellent (and free!) public transport.

**Accompanying persons** can choose among two tours to explore Luxembourg on Friday June 9, 2023. Congress participants and partners arriving early have the opportunity to participate in a tour of the Court of Justice in the morning of 8 June. The Congress will be opened on Thursday June 8, 2023 at 4pm, in the **Hemicycle** room of the ECCL, followed by the General Assembly.

It is a great honour and pleasure during the welcome ceremony to welcome a lecture held by **Judge Prof. Dr. Tamara Perišin**, who will speak on a topic concerning taxation and the role of the General Court.

The first day will close with an informal **Get-Together** in the panoramic room of the ECCL.

The **working sessions of the congress** will be held all day on Friday, June 9, 2023 (at the ECCL/Hemicycle) and Saturday, June 10, 2023 until noon (at the Law Department building).

In addition to EATLP (Associate) Members, there is a **limited number of places** available for interested persons to attend the Congress. We especially welcome doctoral students (at a reduced congress participation rate), post-doc fellows and other academics to attend the Congress and we encourage everyone who is interested to register as soon as possible.
