### **Wolfgang Gassner Postdoctoral Fellow in International Tax Law\***

The position will start ideally from **September 1st, 2023** unless otherwise agreed, with a duration of two years.

**Selection Criteria**

- Well-developed communication and interpersonal skills and willingness to work collaboratively with researchers from an international and multidisciplinary background.
